Accra Brewery Limited, originally known as Overseas Breweries Limited, was registered on 30th June, 1931, for the purpose of establishing a brewing industry in the then Gold Coast. It was the first brewing industry

in the whole of West Africa and, indeed, the first non-traditional manufacturing industry in the Gold Coast.

On 1st April 1975, the assets of the former Overseas Breweries Ltd. were taken over by the locally registered ACCRA BREWERY LIMITED to pave the way for Ghanaian participation in the business.

In 1997, SABMiller plc (then South African Breweries) acquired controlling shares in the company.

Today, Accra Brewery Limited is a public Company engaged in the manufacture and distribution of beer, sparkling soft drinks and non-alcoholic malt beverages.
